- 1. 101 Builders, Inc., has a valid California contractor license. License is current and active.
- 2. Their proposed Surety Company, The Fidelity and Deposit Company of Maryland is licensed to do business in California and is rated A+ (Superior) by A.M. Best Rating Center.
- 3. Their recent and experience indicates that they are financially capable and posses the resources to perform on a project of this magnitude.
- 4. Their bid documents appear to be in order with all required submissions.
- 5. After publishing this project in the Daily Post, five (5) bids were received:

In conclusion, based upon the above, it is our recommendation that the District award the contract for the **DO Reconfiguration Project** in the amount of Two Hundred Fifty-Nine Thousand One Hundred One Dollars (\$259,101.00) to 101 Builders, Inc. This amount includes the base bid of \$234,101.00 plus a \$25,000.00 allowance for unforeseen conditions.


