

**AMENDMENT NO. 1  
TO  
INDEPENDENT CONTRACTOR AGREEMENT FOR AUDIT SERVICES MEASURE G BOND**

This Amendment No. 1 to the Independent Contractor Agreement for Audit Services, Measure G Bond ("Amendment") is made and entered into on May 31, 2018, between **Christy White Associates** ("Contractor") and **Mountain View Whisman School District**, a California public school district located in Mountain View, California ("District"). Contractor and District may be referred to herein individually as a "Party", and collectively as the "Parties".

**RECITALS**

- A. WHEREAS, Contractor and District previously entered into an Independent Contractor Agreement for Audit Services Measure G Bond, dated as of February 17, 2016 ("Agreement");
- B. WHEREAS, it is now the desire and intention of the Parties to amend the Agreement to extend the term of services to be performed by Contractor under the Agreement as indicated in this Amendment.

NOW, THEREFORE, in light of the foregoing facts and in further consideration of the promises and agreements of the Parties set forth herein below, it is mutually agreed as follows:

**TERMS AND CONDITIONS**

- I. **Amend** Section 2 of the Agreement, captioned "Term", with the following additional language:

Upon the date of the District's governing Board's approval of the June 30, 2018, audit report, the Agreement will commence to run for an additional three (3) year term, under the same terms and conditions contained in the Agreement. The additional three (3) year term shall expire when the District's governing Board approves the June 30, 2021, audit report, which is intended to be, but is not guaranteed to be prior to September 30, 2021.

- II. **Amend** Section 4 of the Agreement, captioned "Compensation", with the following additional language:

- 4.4. \$3,000 through June 30, 2019
- 4.5. \$3,000 through June 30, 2020
- 4.6. \$3,000 through June 30, 2021

- III. The Parties acknowledge that this Amendment is subject to approval or ratification by the District Board of Trustees ("Board").

- IV. All other provisions of the Agreement shall remain in full force and effect and are reaffirmed. If there is any conflict between this Amendment and any provision of the Agreement, the provisions of this Amendment shall control.
