- The new structure will be adjacent to, and supplement the existing Play Structure that was previously installed.
- The new Structure will be designed and selected from options based on the same manufacturer's products and components as the existing structures throughout the District.
- The new Structure will include synthetic turf surfacing and new concrete curbs beneath and surrounding the Play Structure.

#### **EXLUDED**:

**Underground Utility Locating:** The District has provided copies of the most recent Topographic Surveys for the site. It dates to when the temporary portable housing was still on site. DTA's services *will* include supplemental surveying to gather current as-built information. However, this will *not* include subgrade utility locating in the area of work.

**Supplemental Surveying:** updated Surveying information shall be provided under a separate proposal directly to the Owner.

## Owner Provided Items

Owner shall provide the following information for Architect and Engineers use:

 Topographic and Utility Survey - updated Surveying information shall be provided under a separate proposal directly to the Owner.

The Owner shall make this information available for use by the Architect and Engineer.

### Fee

Architectural & Engineering Fees will cover services described above except for items defined as additional services. Items considered to be additional services will be identified prior to performance of those services and will proceed only upon written authorization from the Owner.

Expenses required as part of the Project are estimated below. Reimbursable expenses not included in the contract will be billed at cost.

Fees and other charges will be billed on or about the first day of each month for services rendered during the previous month. Invoices will be due and payable within twenty days from the date of invoice. Invoices remaining unpaid for thirty days from date of invoice will be considered past due and may be cause for termination of work. Invoices remaining unpaid for forty-five days will be grounds for termination of any agreement existing between the Owner/Client and the Architect.
