RE: Change Order 5 Justification: Stevenson Elementary School, Phase 2 – Increment 1 Sitework Galeb Paving, Inc. – Mountain View Whisman School District

Item #1 – Construct Ramp over AT&T Fiber Optic Line (PCO 12)

This change is the result of an unforeseen condition. During construction a AT&T fiber optic line was discovered to run below the building pad at Building A. While waiting for AT&T to relocate the line the contractor was required to construct a temporary ramp over the utility to protect it during construction. **\$3,831.23**

Item # 2 – Landscape Sleeves (PRO 21)

This change is the result of a District request. In order to provide additional green space to the campus, the District added several planting areas throughout the campus. The planting and irrigation were performed under a separate contract, however, to access the areas without the need to trench through new concrete and asphalt, sleeves were added to this contract to be installed prior to placement of the new hardscape. **\$2,241.89**

Item # 3 – Relocate Stored Material for MUR Contractor Operations (PCO 38)

This change is the result of a District request. In order to allow the MUR contractor adequate staging area to complete lime treatment operations adjacent to the project, stored materials on this project were relocated. The cost included with item no. 3 includes the labor and equipment required to relocate the material. **\$956.65**

Item #4 – Added Ramp and Handrail at Building B (PCO 71r2)

This change is the result to a design revision. During grading around the south end of building B it was discovered that the concrete walkway in this area exceeded the allowable 2% max cross slope required for ADA. As there was no way to adjust the grading in this area to reduce the slope, a concrete ramp with handrail was installed. **\$14,701.01**

Item # 5 – Added Electrical Conduit Between Building A1 (Administration Building) and A2 (Kinder Building) (PCO 86)

This change is a result of a design revision. The electrical and data conduits required to run between buildings A1 and A2 were not shown on the bid documents for this project. In order to provide connection to building A2, the underground conduit was added to this contract. **\$7,252.50**

Item # 6– Fire Line Conflict with Electrical Lines (PCO 97)

This change is the result an unforeseen condition. During installation of the fire water line, an unforeseen electrical conduit was discovered in close proximity to the new fire line. In order to protect the existing electrical service, the contractor was required to hand dig around the line which resulted in an additional labor expense. **\$899.47**

Item # 7– Grade Changes at Building C (PCO 112)

This change is the result to a design revision. During grading around the south end of building C it was discovered that the concrete walkway in this area exceeded the allowable 2% max cross slope required for ADA. In order to correct this issue, the existing asphalt adjacent to the walkway was cut back and regrading in order to reduce the slope to within ADA tolerances. **\$4,612.92**

Total Change Order No. 5 - \$34,488.67

In our capacity as the District's Construction Manager we have completed a review of Change Order #5.

Change orders to date total \$317,007.26 which equates to 8.56% of the contract value. To date, Galeb Paving, Inc. construction has completed 100% of the contract work.

There is \$53,192.74 remaining in the Change Order Contingency.

Based upon the review of the merit and the compensation, it is our recommendation that you approve this change order. If you have any questions, please do not hesitate to call.
