Mistral Elementary

Plan of action for Mistral Elementary

Phase I (2019-20)- Strengthen our program to fulfill purpose

- Strengthen and balance Spanish and English literature instruction.
- Continue intensive planning sessions with staff.
- Implement system to assess students' skills in both languages.
- Implement Eureka Math.
- Strengthen Designated ELD and balance with SLD.
- Refine RTI program to meet unique needs at Mistral.

In 2019-20, Mistral will move from a 90/10 Spanish/English model to a 50/50 model in order to better serve all of Mistral's students.



School Safety

School Safety

- Planning Dates
 - Sept All sites and Departments trained staff on safety protocols
 - Oct 15th Emergency preparedness drill
 - Oct 26th Staff worked with MVPD and middle schools to plan how to roll out Run Hide Defend training for students, as well as a safety drill
 - Oct Jan logistic coordination with MVPD
 - November 27th Active Shooter training for substitute teachers

Opportunities for Growth

- Review other potential videos or move to lockdown drills next year (elementary schools)
- Provide more and better examples in Run Hide Defend presentation (how to barricade rooms)
- Set up time for MVPD to meet with LT to answer questions and provide guidance
- Plan for incidents at all times of the day with all involved (lunch, dismissal)
- Be sure that all schools are consistent with messaging to parents on how to opt out
- Contact Swing (external substitute company) and set up a time for training
- Plan with schools to include all personnel and students on each site (Transportation and Child Nutrition were not involved in drill)



Science

Process and Progress- Elementary Option 1

Traditional Science Program (classroom teacher driven)

- Rationale: All elementary teachers should be knowledgeable about and able to provide quality science instruction.
- Description: Engaging science instruction using updated materials is delivered at a minimum of 2 days per week by classroom teachers and is integrated across other content areas

Process and Progress- Elementary Option 2

Combination Science Program

Classroom Teacher and Science Teacher

Rationale: All elementary teachers should be knowledgeable about and able to provide quality science instruction.

Description: In this option, teachers would be trained in NGSS and be expected to deliver science content. There would be one dedicated science teacher at each site to do labs that correlate to classroom instruction at least one time per week.

Process and Progress- Elementary Option 3

Option 3: Response to Instruction Model

Rationale: In this option, teachers would be trained in NGSS and be responsible for collaborating with 1-2 other science expert teachers on science instruction. Classroom teachers would be responsible for providing intervention/enrichment.

Description: Engaging science instruction using updated materials is delivered at a minimum of 2 days per week by science expert (RTI) teachers. This team would review the models currently in use at Bubb, Huff and Stevenson as well as look for other exemplars.

Next Steps for 2019-20

- Continue partnership with Santa Clara County Behavioral Health Services
- Train staff on Trauma Informed Practices module using Kognito
- Have three Parent University sessions dedicated to mental health and wellness with support from Santa Clara County Behavioral Health Services
 - Overview of suicide prevention
 - SAFE Talk
 - program that teaches participants to recognize and engage persons who might be having thoughts of suicide and to connect them with community resources trained in suicide intervention
 - The 'safe' of safeTALK stands for 'suicide alertness for everyone'. The 'TALK' letters stand for the practice actions that one does to help those with thoughts of suicide: Tell, Ask, Listen, and KeepSafe.
