#### **Neighborhood Schools**

- 3-year process for boundary and school enrollment changes
  - Stakeholder input, Enrollment Priorities Task
     Force
- Board goal to create neighborhood schools at 450
- Open Jose Antonio Vargas Elementary
- Reduce overcrowding at Bubb, Huff, and Landels



## New Boundaries Impact on Enrollment


### Student movement due to new boundaries

- 540 students moved due to boundary changes
- 95 5th graders stayed at their original schools
- 43 siblings of those 5th graders will stay for 1 year

#### Changes to the enrollment process...

- Based on recommendation from Enrollment Priorities Task Force and Board directive, staff created a Student Placement Exemption process
  - 5th grade students and their siblings could stay at current school for 1 year
- Additionally, any school that is under-enrolled to be a part of a 2nd process
- Parents allowed to select only one choice school during open enrollment

## Welcome Events for Transitioning Students

In response to concerns raised by parents and EPTF, all schools receiving transitioning students created welcome events. Examples of events include:


- Parent meetings hosted by receiving school
- Pancake breakfast
- Ice cream social
- Lunches with teachers & students
- Family playdates
- Kinder potlucks
- Friendship chains



# Impact of Enrollment and Exemptions on Schools

#### **Enrollment** is a moving target

- Enrollment is variable throughout the year:
   Spikes twice throughout the year, September and April.
- Official enrollment count in October to comply with CALPADS



#### **Staffing and Enrollment**

- Certificated staffing is driven by enrollment:
  - TK-3 grade: 24 students
  - 4-5 grade: 30 students
  - 6-8 grade: 33 students
  - Combination classes reduce operating costs
- Held meetings at every site with staffing plans

#### **Use of Portables**

- Last year of Bond program, able to use the existing portables with rental fee
  - Existing rental portables at 3 schools are scheduled to be removed next year (2020-21)
  - Portables funded by Measure G (funds not on-going)
- Used only in 2019-20 to accommodate
  - Excess enrollment due to 5th grade students and their siblings (exempted 1 yr)
  - School communities need to function without dependence on portables



## Decisions and Next Steps

#### **Enrollment exemptions**

- Reasons that exemptions might be made:
  - Title IX civil rights (qualified reasons of harassment, violence or bullying)
  - Special education placement for special day class
  - Active US Military to Monta Loma only
- Of 81 exemptions submitted, 9 qualified, 5 are pending (follow-up of information per Exemptions Committee request)
  - Unapproved requests examples: transportation, afterschool activities, perceptions of school quality
- Since October 2018, we have stated on the form that decisions of the Student Placement Exemption Committee are final; no appeals

#### **Next Steps**

- Notices for exemption requests go out after June 1
- No under-enrolled schools using the Board parameters
  - 3rd Grade Theuerkauf Elementary
- Determine impact to transportation; possible repurpose or reduction in force
- Developing a plan to address verification process for over-enrolled schools
- Per EPTF, does the Board have an interest in diversifying choice schools?
