Description of work:

We will furnish labor and materials to remove and replace two sections of sidewalks, as noted herein:

Area #1 Sidewalk; 2'x 8'

Area #2 Sidewalk; 2'x 8'

Includes:

- Sawcut, break and haul away concrete
- Set forms
- Install #3 dowels & place (2) #3 long ways
- Pour 4" concrete, pour over existing soil
- apply a broom finish

*Owner to provide and install the following items:

- make repairs to any utility's that get damage, water, electric, cable, gas etc.
- strip forms & remove stakes & caution tape

Note - All concrete is subject to random cracking.

We Propose hereby to furnish material and labor — complete in accordance with the above specifications, for the sum of:

Payment to be made as follows:

Full payment due upon completion of job. Amounts past due will incur a monthly service charge of 1.5% or an annual rate of 18%.

All material is guaranteed to be as specified. All work to be completed in a professional manner according to standard practices. Any alteration or deviation from above specifications involving extra costs will be executed only upon written orders, and will become an extra charge over and above the estimate. All agreements contingent upon strikes, accidents or delays beyond our control. Owner to carry fire, tornado, and other necessary insurance. Our workers are fully covered by Worker's Compensation Insurance.
