Item # 1 – Change Admin Melamine to Grey (PCO # 5)

This change is the result of a design revision by District request. After the time of bid, the District decided to change the color of the melamine at the Administration Mail Room in order to meet the district standard that has been recently installed throughout the district. The costs associated with Item No. 1 is the difference in pricing for the changes noted above. \$2,940

Item #2 – Remove Upper Cabinet at Library Staff Room (PCO 9)

This change is the result of a design revision. After the time of bid, the district upgraded the IDF cabinet at the Library staff room to a district standard cabinet. In order for the new cabinet to fit, one of the upper cabinets needed to be removed. The cost associated with Item No. 2 is for the labor required to remove said cabinet. \$748

Item #3 – Weatherization at Foundations (PCO #10r1)

The change is the result of unforeseen conditions. In order to allow the various contractors to perform work through the abnormally high amount of rain received, a concrete slab was poured between the footings. The costs associated with Item No. 3 are for all labor and material required to install the slab. \$10,500

Total Change Order No. 3 - \$14,188

In our capacity as the District's Construction Manager we have completed a review of Change Order # 3.

The total of previous Change Orders: \$144,925

The total Change Orders to date: \$159,113

This equates to 5.82% of the contract value. To date, Enviroplex has completed 97% of the contract work.

There is \$116,533.78 remaining in the Change Order Contingency.

Based upon the review of the merit and the compensation, it is our recommendation that you approve this change order. If you have any question, please do not hesitate to call.
