RE: Change Order #2 Justification: Castro/Stevenson Playground Extension – Terramark- Mountain View Whisman School District.

Item # 1 – Irrigation and Sod as requested by the City (PCO 2)

This change is due to a request by the City of Mountain View parks department. The city requested several existing irrigation heads be relocated outside of the work area in order to provide better watering coverage over the existing Stevenson Field. Additionally, the amount of existing sod needing restoration was greater than originally anticipated at bid time for this project. This change order also includes other miscellaneous added costs necessary to restore and modify the Stevenson Field per the city of mountain view's requests, such as raising utility boxes to grade, fertilizing existing sod, etc. The costs for this change include the added labor costs to the overall landscaping scope, as requested by the City of Mountain View, as well as the added material costs to furnish additional quantities of sod, pipe material and fertilizer. \$10,282.00

Total Change Order No. 2 – \$10,282.00

In our capacity as the District's Construction Manager we have completed a review of Change Order # 2.

The total Change Orders to date: \$14,354.00

This equates to 4.33% of the contract value. To date, Terramark has completed 98% of the contract work.

There is \$7,046.00 remaining in the Change Order Contingency.
