Proposal for Architectural Services

The following is a Proposal for the performance of Architectural & Engineering Services. Upon acceptance of this Proposal by the Owner, work shall commence.

Project

Monument Sign Relocation Vargas Elementary School 220 N. Whisman Road Mountain View, CA 94043

Intentions and Considerations

- The District (MVWSD) would like to relocate the LED scrolling marquee / monument sign at Vargas Elementary School.
- The existing sign was installed as part of the opening of the new Vargas Elementary School. However, the City of Mountain View required that a new street signal pole be installed in a location immediately in front of the monument sign.
- The District has selected a new location for the sign that is across the existing driveway, adjacent to the sidewalk that is in front of the new softball field.
- The scope of work will include the following:
 - Preparation of Preliminary Architectural Site Plan for review by the District, Site Administration, and School Board
 - Demolition of the existing monument sign pedestal with salvaging of the LED sign
 - Construction of the new pedestal in the new location
 - Installation of salvaged LED sign at new pedestal
 - Extension and connection of existing power and data to the new sign location
 - Adjustments to Landscaping and irrigation as necessary
 - Adjustments to adjacent vinyl-coated chain link fencing as necessary

Services

DTA and their consultants will provide the following services Phase 1: Preliminary Site Plan for District Review:

- Site Scoping Meeting w/ Consultants & Greystone
- Prepare a preliminary Site Plan and photo montage for review by the District, the Site Administration, and the School Board

Phase 2: Schematic Design (NOT USED)

Phase 4: Construction Documents

Following approval of the proposed location for the new Sign, DTA and their consultants will develop the Construction Documents for bidding and construction.

- DTA and their consulting Engineers, will produce the Construction drawings. Details for the sign will be based on the previous design that was constructed as a District standard, at Vargas and other school sites.
- District / Greystone coordination for cost estimating, site access, and utility information.
- Consultant coordination
- Specs and other prep for bidding

- District / Greystone coordination pre-proposal conference, bid review/input

Fee

Architectural Fees are proposed on a *fixed fee basis*, and will cover services described above except for items defined as additional services. Items considered to be additional services will be identified prior to performance of those services and will proceed only upon written authorization from the Owner.

Expenses required as part of the Project are estimated below. Reimbursable expenses not included in the contract will be billed at cost.

Fees and other charges will be billed upon completion of each phase of work. Invoices will be due and payable within twenty days from the date of invoice. Invoices remaining unpaid for thirty days from date of invoice will be considered past due and may be cause for termination of work. Invoices remaining unpaid for forty-five days will be grounds for termination of any agreement existing between the Owner/Client and the Architect.
