RE: Change Order #2 Justification: Kenneth Slater New Campus Project Increment 4 – Rodan Builders-Mountain View Whisman School District – DSA APP #: 01-117942

Item # 1 – Offsite Design Revisions (PCO's 12, 21,23, 25r2, 26 & 27)

These changes are the result of design revisions. Due to the timing of the DSA review process as a result of the various increments of construction, the full scope of offsite work was not known at the time of bid. After the time of bid changes were made to the ADA concrete, crosswalk striping, traffic signals, island pavers and the PG&E signal trench to accommodate both City of Mountain View and District standards. The costs associated with Item No. 1 are for all labor, equipment and materials required to make the above noted changes. **\$51,838.00**

Item # 2 – Various District Requested Changes (PCO's 9, 14, 17r1)

These changes are the result of district requests. In order to meet uniformity across all sites, the district chose to add televisions to the Flex classrooms, wax and seal the tile floors and also painted the exterior of the portable classrooms to match the rest of the site. The costs associated with Item No. 2 are to furnish and install the previously noted changes. **\$31,482.00**

Item # 3 – Offsite Unforeseen Conditions (PCO's 10 & 20r1)

These changes are the result of unforeseen conditions. It was discovered after the time of bid that the existing tree on the south side of the driveway conflicted with the new ADA path of travel to the site and needed to be removed. Additionally, there was an abandoned concrete storm drain line found at the base of the new traffic signal at the southeast corner of N Whisman and Pacific Ave. The costs associated with Item No. 3 are to remove the tree and cut, remove and plug the existing storm drain ends with concrete per CMV request. **\$12,519.22**

Item # 4 – Onsite Design Revisions (PCO's 15 & 19)

These changes are the result of various design revisions. After the time of bid, an elevator shunt-trip & dedicated circuit were added to accommodate code requirements. Costs associated with Item No. 4 are for all labor and materials required to install the new shunt-trip and associated dedicated circuit. **\$13,721.00**

Item # 5 – Onsite Unforeseen Conditions (PCO's 8r1, 11, 16 & 18)

These changes are the result of unforeseen conditions. Various unforeseen conditions arose during construction requiring exterior wall cut and patch work, closure panels, final plumbing connections and Additional data installation. Costs associated with Item No. 5 are for all labor and materials to complete the above noted changes. **\$5,866.00**

Item # 6 – Deduct for Balance of Owner Controlled Change Order Contingency included in the Lease-Leaseback Contract

The Guaranteed Maximum Price (GMP) contract for this project included a \$202,346 owner-controlled construction contingency. Change Order No. 1 was processed and approved previously by the Board of Trustees to document billing against that contingency. Change Orders 1 & 2 total \$202,073.22 leaving a balance remaining of \$272.78. The balance of the contingency funds is now being deducted from the contract sum and credited back to the District. (**\$272.78**)

Total Change Order No. 2 - \$115,426.22

In our capacity as the District's Construction Manager we have completed a review of Change Order # 1.

The total Change Orders to date: \$202,073.22

This equates to 9.07% of the contract value. To date, Rodan has completed 100% of the contract work.

There is \$0 remaining in the Change Order Contingency.

Based upon the review of the merit and the compensation, it is our recommendation that you approve this change order. If you have any question, please do not hesitate to call.
