CLARIFICATIONS: Union Wages

- Any deposits or payments required by Suppliers or Manufacturers shall be required from the Owner or General Contractor prior to ordering or delivery.
- On-grade planting areas shall be received in a clean condition with areas to drain, at finished grade ± 0.1 foot.
- Any on-structure planting areas shall be received in a clean condition with areas to drain.
- Any aggregate-surfacing, unit-paver, or biofiltration areas shall be received in a clean condition, at subgrade ± 0.1 foot
- Pull string for control wiring in conduit through-structure shall be supplied by others
- Planting shall begin when water and electrical hookups are completed. If water or electrical utility service were to fail during the post-installation maintenance period, then hand watering would cost \$2,500.00 per month.
- If landscape or irrigation were to be damaged by causes beyond our control, then any required repairs would be done as a time-and-materials addition to the Base Bid.
- This proposal shall be a part of any contract awarded to Eggli Landscape Contractors, Inc.
- One electronic set, or three paper copies, of current plans are required before commencement of any work.
- Additional relocation of site furnishings after delivery but before final placement shall be at additional cost.
- Proposal valid for Sixty Days.
