#### **Article 6. Fee and Method of Payment**

District shall pay Consultant for all Services contracted for under this Addendum, and subject to the terms of this Agreement, an amount not to exceed **Twenty-Eight Thousand Dollars**(\$28,000.00), paid on a monthly progress billing basis for which Consultant shall bill its work under this Agreement in accordance with **Exhibit D** to the Agreement.
