## **Item #1 – Credit for Incomplete Work (PCO 8)**

This Credit is due to Incomplete work by the Contractor. There was a small, 1-foot by 2-foot, section of asphalt not replaced by the contractor, underneath the one of the new HVAC unit Chain Link enclosures, behind the Montecito Ave Portable Village; as well as a small quantity of spoils off haul that was not removed. This credit includes the costs of the work not completed by the contractor. (\$2,500.00)

## **Total Change Order No. 3 – (\$2,500.00)**

In our capacity as the District's Construction Manager we have completed a review of Change Order # 3.

The total Change Orders to date: \$13,640.09

This equates to 4.75% of the contract value. To date, Galeb has completed 100% of the contract work.
