

- Site Survey of existing site electrical systems for available power and low voltage connection points for new electric gates strikes.
- Coordinate with gate manufacturer for power and low voltage requirements.
- Provide electric circuits for all gates connected to existing panels on site.
- Provide time clock and low voltage control diagrams as required.
- Provide site plans with conduit pathways for all systems.
- Provide electrical specifications including materials and installation requirements.
- Coordinate drawings requirement with client and DSA plan check and review.
- Answer pre-bid and/or bid questions.
- Answer Requests for Information (RFIs) during construction.
- Review submittals and shop drawings.


