- 1) Golden Bay Fence plus Iron Works, Inc. has a valid California Contractor's License with 'C13 – fencing' classification. The License is current and active.
- 2) Their proposed surety company, Fidelity and Deposit Company of Maryland, is licensed to do business in California and is rated A+ (Superior) by A.M Best Rating Center.
- 3) Their recent and past experience indicates that they are financially capable and possess the resources to perform on a project of this magnitude.

The construction budget for this project was \$1,872,293. The bid received from Golden Bay Fence plus Iron Works, Inc. is within budget.

In conclusion, based upon the above, it is our recommendation that the District award the contract for the **District-Wide Campus Perimeter Controls Upgrades Project Phase 2** in the amount of Two Hundred Sixty-Nine Thousand Eight Hundred Forty Dollars (\$269,840.00) to Golden Bay Fence plus Iron Works, Inc.
