RE: Crittenden and Vargas Marquee Project

In our capacity as the District's Construction Manager, we have completed a review of the Bid Proposals submitted by all prospective bidders for the **Crittenden and Vargas Marquee Project** that was bid on Thursday, April 15, 2021 at 2:00 p.m. In our review, we found that Escon Builders has submitted the responsive and responsible low bid for the subject project.

- 1. Escon Builders has a valid California contractor license. License is current and active.
- 2. Their proposed Surety Company, American Contractors Indemnity Company is licensed to do business in California and is rated A++ (Superior) by A.M. Best Rating Center.
- 3. Their recent and experience indicates that they are financially capable and posses the resources to perform on a project of this magnitude.
- 4. Their bid documents appear to be in order with all required submissions.
- 5. After publishing this project in the Daily Post, two (2) bids were received:

Escon Builders - \$196,000 101 Builders - \$216,101

The construction budget for this project was \$154,601. The bid received from Escon Builders was 26% or \$41,399 over budget. We believe the overage is a result of a few contributing factors: (1) Due to the relatively small size of the project and specialized trades involved there was not much interest in the project resulting in only 2 firms

bidding, (2) recent material cost increases impacting metals increased the price of electrical conduit for the project. We do not see these two items improving in the near future and do not believe the District would benefit from re-bidding the project. Greystone West and the Design firm will work with the contractor to bring the overall project closer to budget.

In conclusion, based upon the above, it is our recommendation that the District award the contract for the **Crittenden and Vargas Marquee Project** in the amount of One Hundred Ninety-Six Thousand Dollars (\$196,000.00) to Escon Builders.


