A motion was made by Laura Blakely and seconded by Ellen Wheeler to approve new Board Policy (BP) 6158 Remote Independent Study at first reading.

Staff presented the Trustees with the new Board Policy (BP) 6158 Remote Independent Study. This policy is specifically for the 2021-2022 school year only for the duration of AB130.

C. Remote Independent Study 2021-22 (30 minutes)

A motion was made by Laura Berman and seconded by Laura Blakely to approve the long term independent study option and Edgenuity contract for the 2021-22 school year.

The Governor approved AB130 on July 9, 2021. The long-term independent study was added for the 21-22 school year with additional requirements. AB130 requires all districts to offer an Independent Study Program to students whose health would be put at risk by in-person instruction, as determined by the parent/guardian for the 2021-22 school year. Staff presented the Trustees with a Remote Independent Study plan for the 2021-22 school year and recommended Option 5; Contracting with Edgenuity (online independent study program, teachers provided through edgenuity, workbooks provided for elementary student's, progress monitoring data available)

A motion was made by Laura Blakely and seconded by Christopher Chiang to approve capping enrollment in the choice schools for students whose families enroll them in the Independent Study Program for the 2021-2022 school year.
