Item #1 – Relocate 1 Data Jack at Each Classroom for Connection of New Public Address System Device (COR 2)

This change is the result of an unforeseen condition. During installation of the new public address system, it was discovered the existing data drop location was too far away from the new PA devices and would need to be relocated in order to avoid exposed cabling in the classrooms. The cost included for item no. 1 includes all labor and material required to relocate one data drop in each of the 42 rooms. **\$8,882.91**

In our capacity as the District's Construction Manager, we have completed a review of Change Order #2.

The total cost of Change Order #2 is: \$8,882.91

The total Change Orders to date is \$34,616.31

There is \$0 remaining in the change order contingency for this project after Change Order No. 2.
