Jason Cave presented an update on all current projects. Highlights include: Solar is on schedule but car chargers are delayed due to supply chain issues. All summer 2023 solar is into DSA. HVAC is in DSA for summer 2023 but we are seeing an increase in the time it takes for DSA to process. Site lighting is in process and is DSA review only. Working on window replacement project. Community restrooms are on schedule. Vargas carport project is about 6 weeks behind schedule due to an additional request for geotechnical calculations from DSA. Paving at Bubb, Imai, and CR is on schedule.
