RE: Imai Site Package for Portable Project – Award of Contract/Bid

In our capacity as the District's Construction Manager, we have completed a review of the Bid Proposals submitted by all prospective bidders for the **Imai Site Package for Portable Project** that was bid on Thursday, February 10, 2022, at 2:00 p.m. In our review, we found that Silicon Valley Paving, Inc., has submitted the responsive and responsible low bid for the subject project.

1. Silicon Valley Paving, Inc., has a valid California contractor license. License is current and active.
2. Their proposed Surety Company, Ohio Casualty Insurance Company is licensed to do business in California and is rated A (Excellent) by A.M. Best Rating Center.
3. Their recent and experience indicates that they are financially capable and possess the resources to perform on a project of this magnitude.
4. Their bid documents appear to be in order with all required submissions.
5. After publishing this project in the Daily Post, six (6) bids were received:


Silicon Valley Paving -	\$231,000
ELECCO -	\$267,900
BuildCorp -	\$325,000
Escon Builders -	\$326,800
Premier Builders -	\$388,369
Galeb Paving -	\$426,450

The construction budget for this project was \$179,500. The bid received from Silicon Valley Paving, Inc., exceeds this budget by \$51,500. After speaking with bidders for this project the overage is primarily attributed to recent increases in material cost due to supply chain issues. Concrete, paving and electrical components were the largest portions of this project impacted by material cost increases. The excess funds would be pulled from the overall program contingency to cover the overage.

In conclusion, based upon the above, it is our recommendation that the District award the contract for the **Imai Site Package for Portable Project** in the amount of Two Hundred Thirty-One Thousand Dollars (\$231,000.00) to Silicon Valley Paving, Inc.
