In our capacity as the District's Construction Manager, we have completed a review of the Bid Proposals submitted by all prospective bidders for the **Paving Upgrades at Bubb ES, Imai ES and Crittenden MS Project** that was bid on Tuesday, April 5th, 2022, at 2:00 p.m. In our review, we found that Tri Valley Excavating, Inc., has submitted the responsive and responsible low bid for the subject project.

1. Tri Valley Excavating, Inc. has a valid California contractor license with an A - General Engineering, B - General Building and C12 - Earthwork and Paving classification. License is current and active.
2. Their proposed Surety Company, The Ohio Casualty Insurance Company is licensed to do business in California and is rated A (Excellent) by A.M. Best Rating Center.
3. Their recent and past experience indicates that they are financially capable and possess the resources to perform on a project of this magnitude.
4. Their bid documents appear to be in order with all required submissions.
5. After publishing this project in the Daily Post, and holding a non-mandatory pre-bid conference, seven (7) bids were received:

Tri Valley Excavating, Inc.	\$599,616.00
DRT Grading & Paving	\$638,000.00
Silicon Valley Paving, Inc.	\$675,000.00
Galeb Paving, Inc.	\$774,200.00
O'Grady Paving, Inc.	\$867,000.00
Cato's Paving	\$867,645.00
Guerra Construction, Inc	\$877,740.00

The construction budget for this project was \$800,000.00. The bid received from Tri Valley Excavating, Inc., was within the allotted budget.

In conclusion, based upon the above, it is our recommendation that the District award the contract for the **Paving Upgrades at Bubb ES, Imai ES and Crittenden MS Project** in the amount of Six Hundred and Forty-nine Thousand Six Hundred and Sixteen Dollars (\$649,616.00) to Tri Valley Excavating, Inc. This amount includes the base bid of \$599,616 plus a \$50,000 allowance for DSA comments or unforeseen conditions.
