MVWSD is utilizing ESSER III funds to continue key programs from the other district plans referenced above (LCAP, Expanded Learning Opportunities Grant). In Spring 2021, MVWSD completed a robust community engagement and feedback process to inform these plans, and by extension, this ESSER III Expenditure Plan.

First, we determined what the needs are for learning recovery by asking our stakeholders. In April 2021, each school site held a series of meetings with stakeholders from all constituency groups. Interpretation was provided, as were additional outreach and supports for families who needed accommodations to be able to attend. Some sites utilized surveys for students. These feedback sessions were not not solutions-oriented, but intended to accurately ascertain needs (not wants). Principals took parents and staff members through the process using the Root Cause protocol. The District also used a similar process with its District Advisory Committee (DAC), District English Learners Advisory Committee (DELAC), and district level parent groups such as the Mountain View Educational Foundation and the PTA Presidents' group.? The Board of Trustees publicly reviewed the results of this needs assessment and tentative Learning Recovery actions on May 6th. All of the Learning Recovery Plan feedback session dates are here: <a href="http://mvw.sd/QS8HB">http://mvw.sd/QS8HB</a>. This feedback was used to inform draft strategies for learning recovery.

During the month of May 2021, more stakeholder feedback was gathered on proposed site and District strategies for learning recovery. The plan was refined and proposed to the Board of Trustees for approval on May 20. Over the course of summer and at the beginning of the school year, informal community feedback was solicited at events such as the bi-monthly Superintendent Check-In meetings that are open to all community members.

During our community engagement process, stakeholders were clear about their concern about academic and social emotional issues exacerbated by distance learning during a significant part of the 2019-20 and 2020-21 school years. These issues are not only being addressed in the ESSER III plan, but also in our 2021-24 LCAP and the Expanded Learning Opportunities plan. ESSER III funds will be used to fund Instructional Coach positions for three schools, an Educational Services Coordinator for Expanded Learning and Targeted Tutoring, and site-specific efforts to address specific needs in the academic and social-emotional realms.

Our stakeholder input also revealed persistent internet connectivity issues, especially among our most socioeconomically disadvantaged groups. While past and current efforts to provide hotspots and connect families to free services provided by the local internet service providers have successfully addressed the issue for some families, other groups, such as McKinney-Vento families and those living in areas where wireless connectivity is poor or wired connectivity is so dense that proper network service is disrupted, still do not have reliable internet access, reducing their ability to utilize academic supports at home. Our plan commits significant funds to build a Citizens Broadband Radio Service (CBRS) network which will provide district internet coverage to families living within a 0.5 mile radius of each school, covering an estimated 80% of all families. The vast majority of the families who will be covered by CBRS are those who currently have the biggest internet connectivity challenges.

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

  - Purchasing education technology (including hardware, software, and connectivity) for students who are served by the LEA that aids
    in regular and substantive educational interaction between students and their classroom instructors, including low-income students
    and children with disabilities, which may include assistive technology or adaptive equipment;
  - Providing mental health services and supports, including through the implementation of evidence-based full-service community schools;
  - Planning and implementing activities related to summer learning and supplemental after school programs, including providing classroom instruction or online learning during the summer months and addressing the needs of underserved students;

- o Addressing learning loss among students, including underserved students, by:
  - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
  - Implementing evidence-based activities to meet the comprehensive needs of students,
  - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
  - Tracking student attendance and improving student engagement in distance education;

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to
