### RE: Vargas Elementary School Parking Cover Project – Award of Contract/Bid

In our capacity as the District's Construction Manager, we have completed a review of the Bid Proposals submitted by all prospective bidders for the **Vargas Elementary School Parking Cover Project** that was bid on Tuesday, April 19, 2022, at 2:00 p.m. In our review, we found that RC Benson & Sons, Inc., has submitted the responsive and responsible low bid for the subject project.

- 1. RC Benson & Sons, Inc., has a valid California contractor license. License is current and active.
- 2. Their proposed Surety Company, Everest Reinsurance Company is licensed to do business in California and is rated A+ (Superior) by A.M. Best Rating Center.
- 3. Their recent and experience indicates that they are financially capable and posses the resources to perform on a project of this magnitude.
- 4. Their bid documents appear to be in order with all required submissions.
- 5. After publishing this project in the Daily Post, two (2) bids were received:

RC Benson & Sons, Inc. \$635,899 Rodan Builders \$649,000

The construction budget for this project was \$397,855. The bid received from RC Benson & Sons, Inc., exceeds this budget by \$238,044. After speaking with bidders for this project the overage is primarily attributed to recent increases in material cost due to supply chain issues as well as changes made during the Division of the State Architect

(DSA) review process. Concrete, steel and electrical components were the largest portions of this project impacted by material cost increases. The excess funds would be pulled from the overall program contingency to cover the overage.

In conclusion, based upon the above, it is our recommendation that the District award the contract for the **Vargas Elementary School Parking Cover Project** in the amount of Six Hundred Thirty-Five Thousand Eight Hundred Ninety-Nine Dollars (\$635,899.00) to RC Benson & Sons, Inc.
