- Furnish and install (1) new 3 pole 100-AMP breaker to match existing type in panel MSB-A. (Breaker not sh
- Furnish and install (1) new 3 pole 60-AMP breaker to match existing type in panel MSB-A.
- Provide shut down of main switch gear to install all breakers listed above. (We assume for this work to be provided during normal working hours. We expect this shut down to happen in two phases on two separate days to allow for ample time to remove and replace the breakers.)
