RE: HVAC Modernization & Replacement Phase 3 Project

In our capacity as the District's Construction Manager, we have completed a review of the Bid Proposals submitted by all prospective bidders of the **HVAC Modernization & Replacement Phase 3 Project** that was bid on Wednesday October 12th, 2022 at 2:00 pm. In our review, we found that Foothill Air Conditioning and Heating Inc, has submitted the responsive and responsible low bid for the subject project.

- 1) Foothill Air Conditioning and Heating Inc, has a valid California Contractor's License with 'B General Building', 'C20 Warm-Air Heating, Ventilating and Air-Conditioning' and 'C43 Sheet Metal' classifications. Their License is current and active.
- 2) Their proposed surety company, Everest Reinsurance Company, is licensed to do business in California and is rated A+ (Superior) by A.M Best Rating Center.
- 3) Their recent and past experience indicates that they are financially capable and possess the resources to perform on a project of this magnitude.
- 4) Their bid documents appear to be in order with all required submissions.
- 5) After publishing this project in the Daily Post, two (7) bids were received:

The construction budget for this project was \$450,000.00. Foothill Air Conditioning and Heating Inc's Bid was within this budget.

In conclusion, based upon the above, it is our recommendation that the District award the contract for the **HVAC Modernization & Replacement Phase 3 Project** in the amount of Three Hundred and Twelve Thousand Dollars (\$312,000.00) to Foothill Air Conditioning and Heating Inc. This amount includes a base bid amount of Two-hundred and Sixty-two thousand dollars (\$262,000.00) and a Thirty-Thousand-dollar (\$30,000.00) allowance for Unforeseen condition and an additive alternate #1 of Twenty-thousand dollars (\$20,000.00) per month (1 month included), to provide temporary HVAC units at all affected buildings, in the event of unforeseen excessive lead times for the new mechanical units, that push past the project's construction period.
