

## FIRST AMENDMENT TO CONTRACT [November 3, 2022]

THIS AMENDMENT is made by and between the Mountain View Whisman School District, a California public school district ("District") and Enrique S. Flores ("Consultant/Contractor"). District and Consultant/Contractor may be referred to herein individually as a "Party" or collectively as the "Parties".

## RECITALS

WHEREAS, District and Consultant/Contractor entered into the Contract, dated [November 3, 2022] (the "Contract"); and

WHEREAS, as of the Effective Date [November 17, 2022] the Parties mutually intend to amend the terms of the Contract to effectuate the intentions of the Parties set forth herein this Amendment;

NOW THEREFORE, for the valuable consideration, receipt of which is hereby acknowledged, District and Consultant/Contractor agree to amend the Contract as follows:

## AMENDMENT

- 1. <u>Defined Terms.</u> Except as may be defined herein this Amendment, capitalized terms shall have the meaning prescribed to them in the Contract.
- Speaking engagements for the week of November 14, 2022, United Against Hate, and Revisit Day in February (2/17/23). Mr. Flores charges \$1500 per speaking engagement. End date continues to be June 15, 2023 as stated on original PSA.

- 4. <u>Miscellaneous</u>. This Amendment may be executed in any number of counterparts all of which when taken together shall constitute one and the same document. Except as expressly modified by this Amendment, all other terms and provisions of the Contract are in full force and effect. This Amendment shall be governed and construed in accordance with the laws of the State of California.
