SCOPE OF WORK

Please see our proposal for the above referenced project for your consideration. This proposal is to include labor, materials and equipment for all work in the inclusions noted below. Performance of works will be performed between 7:00 a.m. to 4:30 p.m. Monday through Friday.

PLEASE NOTE:

1. Unforeseen second or third shift work will be a change order
2. Unforeseen material cost increases due to vendor adjustments or discontinued items will be covered in an equitable adjustment change order.
3. Expedited shipping and material production requests may be negotiated and charged on a case by case basis but are not guaranteed
4. A minimum of 30 days from receipt of CAD files and the signing of a contract containing mutually agreed to terms and conditions will be required before submittals and drawings will be available.
5. If a lift or scaffolding is needed and not provided by the GC/EC then CNC will issue a change order to cover the cost of the rental.
6. The district must be running Avigilon Control Center 7.8 or higher for integrating with Halo Sensors
7. Proposal Assumes a free air installation. If surface raceway or conduit is needed it will be covered on a cost change order.
