- 1. Maina Landscape, Inc. has a valid California contractor license. The license is current and active.
- 2. Their proposed Surety Company, Philadelphia Indemnity Insurance Company is licensed to do business in California and is rated A++ (Superior) by A.M. Best Rating Center.
- 3. Their recent experience indicates that they are financially capable and posses the resources to perform on a project of this magnitude.
- 4. Their bid documents appear to be in order with all required submissions.
