RE: Change Order #2 Justification: District Wide Security System Upgrades (Access Control) Project.

## Item #1 – Yale to VonDuprin99 Panic Bar changes (C18)

This change is due to an unforeseen condition. The contractor discovered Eight doors throughout Crittenden MS, Theuerkauf ES and Stevenson ES with existing Yale panic bars. The new AD400 door hardware is not compatible with these Yale panic bars, and thus the contractor was directed to furnish and install eight new VonDuprin99 panic bars, to install the new AD400 door hardware. The costs associated with change include the material and labor costs to furnish and install these new panic bars at each location. \$30,957.78

## Item #2 – Additional Gate Hardware (C19)

This change is due to a Design revision. During the construction process, fourteen additional exterior perimeter gates were added to the project scope to receive new AD400 door hardware, in order to provide a more secure perimeter and a smoother flow of traffic for all campuses. This was done after the contract had been awarded. The costs associated with this change include the material and labor costs to furnish and install \$38,638.03

## **Total Change Order No. 2 – \$69,595.81**

In our capacity as the District's Construction Manager, we have completed a review of Change Order # 2.

The total Change Orders to date: \$98,618.66

To date, **Paladin Technologies** has completed **90%** of the contract work.

There is \$399,940.34 remaining in the construction Contingency.

Based upon the review of the merit and the compensation, it is our recommendation that you approve this change order. If you have any questions, please do not hesitate to reach out.
