Background

CASEL & CDE Guidance

- Collaborative for Academic, Social Emotional Learning (CASEL) provides guidance on comprehensive SEL implementation.
- California Department of Education (CDE) provides guidance on organizational and personnel readiness and SEL competencies.

MVWSD Work Completed

- The SEL Workgroup, a subcommittee of the Health and Wellness Committee, has worked to synthesize California Department of Education guidance.
- Professional Development has focused on building capacity for SEL-integrated instruction and supportive classroom environments.

MVWSD Work Completed

- Data gathering in 23-24 school year included SEL Survey and Student Check-Ins, which was shared in the Health and Wellness Annual Report.
- Community partnerships continue to support student social-emotional development and mental health support



SEL Instruction

SEL Instruction

- Explicit SEL instruction is a component of a comprehensive, competency-based SEL model.
- Identifying and adopting curriculum is a primary component of explicit SEL instruction.
- Currently, there is not a CDE adopted SEL curriculum.
- CASEL SELect programs provide vetted SEL Curriculum that we can turn to for reliable options.
- Our stakeholder input will be vital to narrowing the SEL options to consider.

Considerations

- Important considerations when implementing explicit SEL instruction include, but are not limited to:
 - who provides the explicit instruction,
 - how it is implemented including master schedule impacts,
 - what standards or learning targets does the instruction address,
 - professional development and training needed,
 - developmentally appropriate material, and
 - alignment of instruction and assessment data.

Considerations

- The SEL Workgroup will serve as the SEL Curriculum Adoption committee.
 - Applications for the SEL Workgroup will be opened to wider participation group this year including staff, teachers, parents, and community members.
- All stakeholders will be asked to provide their input on important features, content, and/or SEL needs that will inform SEL Curriculum selection.
