RE: Sitework for Park Restrooms at Various Sites Project

In our capacity as the District's Construction Manager, we have completed a review of the Bid Proposals submitted by all prospective bidders of the **Sitework for Park Restrooms at Various Sites Project** that was bid on Wednesday September 25, 2024 at 2:00 pm. In our review, we found that Rodan Builders, Inc. has submitted the responsive and responsible low bid for the subject project.

- 1) Rodan Builders, Inc. has a valid California Contractor's License with 'A General Engineering,' 'B General Building,' 'C13 Fencing,' and 'C21 Building Moving, and Demolition' classifications. The License is current and active.
- 2) Their proposed surety company, Hartford Fire Insurance Company, is licensed to do business in California and is rated A+ (Superior) by A.M Best Rating Center.
- 3) Their recent and past experience indicates that they are financially capable and possess the resources to perform on a project of this magnitude.
- 4) Their bid documents appear to be in order with all required submissions.
- 5) After publishing this project in the Daily Post, six (6) bids were received:

The bid received from Rodan Builders in the amount of \$722,000 is well above the Board approved schematic design budget for this project which was established in 2021 for construction in 2022. Due to decision to put the project on hold and now reschedule for construction in late 2024 and early 2025, significant escalation and materials cost increases have arisen. Additionally, changes made to building locations during the design phase and changes made to footing and fencing details during the permitting process had an impact on the project budget. As such an increase was anticipated, a revised budget was prepared in late 2023 which included a construction cost for this scope of work at \$774,295 inclusive of contingencies. That value is currently being carried in the Measure T budget for this project.

In conclusion, based upon the above, it is our recommendation that the District award the contract for the **Sitework for Park Restrooms at Various Sites Project** in the amount of Seven Hundred Thirty-Seven Thousand Dollars (\$737,000.00) to Rodan Builders, Inc.


