In our review, we found that Silicon Valley Paving, Inc. has submitted the responsive and responsible low bid for the subject project.

- 1) Silicon Valley Paving, Inc. has a valid California Contractor's License with 'A – General Engineering,' and 'C13 – Fencing.' The License is current and active.
- 2) Their proposed surety company, The Ohio Casualty Insurance Company, is licensed to do business in California and is rated A (Excellent) by A.M Best Rating Center.
- 3) Their recent and past experience indicates that they are financially capable and possess the resources to perform on a project of this magnitude.
- 4) Their bid documents appear to be in order with all required submissions.
- 5) After publishing this project in the Daily Post, six (6) bids were received:

The construction budget for this project was \$501,888.00. The bid received from Silicon Valley Paving, Inc. is within budget at a contract value of \$490,000.00.

In conclusion, based upon the above, it is our recommendation that the District award the contract for the **Monta Loma Elementary School Fencing Improvements Project** in the amount of Four Hundred Ninety Thousand Dollars (\$490,000.00) to Silicon Valley Paving, Inc.
