## Seinfeld's George turned down bribe

Jason Alexander said he was offered a bribe to leak details about the finale of "Seinfeld."

Alexander, who played George Costanza on the show, and Julia Louis-Dreyfus, who played Elaine Benes, took part in a video chat on Tuesday in which they looked back at the excitement surrounding the sitcom's last episode in 1998. Louis-Dreyfus said walls had to be placed around the set to keep paparazzi from taking pictures of the filming.

"And I remember thinking at that time, 'Seriously? Who gives a s\*\*\*?'" she said.

That's when Alexander said he was offered a bribe to reveal details.

"My own publicist — I don't know if this came for you, too — my publicist was asking me if I was willing to leak out some secrets for money. And I went, 'They'll kill us!'" he said.

**FAVRE IN WELFARE SCANDAL:** Former NFL quarterback Brett Favre is repaying \$1.1 million in welfare money that he received for multiple speeches where he did not show up, the Mississippi state auditor said yesterday.

Auditor Shad White said his office received \$500,000 from Favre yesterday, plus a commitment that Favre will repay the other \$600,000 over the next few months.

Favre's effort to repay the money came two days after White released an audit of spending by the Mississippi Department of Human Services that showed Favre had been paid by Mississippi Community Education Center, a nonprofit group whose former leader has been indicted in a welfare embezzlement scheme.

The community education center had contracts with Human Services to spend money through the Temporary Assistance for Needy Families program, also known as TANF.

PLEASE TAKE NOTICE that immediately following a public hearing on the matter, a proposed resolution(s) will be considered by the Governing Board of Mountain View Whisman School District at its regular meeting on May 21, 2020, at 7:00 p.m., which if adopted by the Board will implement development fees established by the District against residential construction and reconstruction at \$2.72 per square foot and against new commercial or industrial construction at \$0.44 a square foot. Education Code Section 17620 and Government Code Section 65995 authorize the proposed fees. Data pertaining to the cost of school facilities is available for inspection on the District website at [mwvsd.org](http://mwvsd.org). The fee, if approved by the Governing Board, will become effective on July 20, 2020, which is 60 days after the proposed adoption of the resolution levying such fee by the Governing Board.
