

**Mountain View Whisman School District
Independent Contractor for Professional Services Agreement
(Non-construction Related)**

THIS AGREEMENT is made and entered into on September 11, 2017 ("Agreement"), by and between and **Mountain View Whisman School District** ("District") and Run for Fun Camps ("Contractor"). Contractor and District may be referred to herein individually as a "Party" or collectively as the "Parties."

1. **Services.** The District is authorized by Gov. Code § 53060 to contract with any persons for the furnishing of special services and advice in financial, economic, accounting, engineering, legal or administrative matters, if those persons are specially trained and experienced and competent to perform the special services required. The Contractor shall furnish to the District the following services ("Services" or "Work"). The Contractor warrants that it is specially trained, licensed and experienced and competent to perform the Services. As indicated in Exhibit "A" or as follows:

Mondays + Tuesdays 9/18-12/12 (no class 10/9 or 10/10)
24 sessions @ \$95 = \$2280 ; 11:15-11:40; 11:50-12:15; 12:20-12:45

2. **Price & Payment.** The Contractor shall furnish the Services to the District for the following compensation:

- Contractor is providing services for a total flat fee of: \$ 2,280 ; or

("Agreement Price"). Payment for the Services shall be made in accordance with the Terms and Conditions. 3. **Agreement Time.** The Services shall commence on September 18, 2017 and shall be completed by December 12, 2017 ("Agreement Time")

4. **Submittal of Documents.** The Contractor shall not commence the Services under this Agreement until the Contractor has submitted the following documents as indicated below (Check all that are required):

Except for worker's compensation insurance, the District shall be named as an additional insured on all policies. Contractor's policy(ies) shall be primary; any insurance carried by the District shall only be secondary and supplemental. Contractor shall not allow any subcontractor, employee, or agent to commence Work on this Agreement or any subcontract until the insurance required of Contractor, subcontractor, or agent has been obtained.
