RE: Change Order #2 Justification: Stevenson Elementary School Portable Village, Phase 1 Rodan Builders Inc. – Mountain View Whisman School District

Item #1 – Plumbing Connections at 6 Portables (PCO 19.3)

This change is the result of a design revision. The contractor could not make a standard tie in to the back of the 6 portables. In order to make the connection the floor had to be opened up and pipe had to be ran underneath the portables and sleeve through floor for connections. The cost for item no. 1 includes labor and material required to provide pluming tie ins and repair the existing floors. **\$14,220**

Item # 2 – Caulking at Concrete Expansion Joints (PCO 24)

This change is the result of a design revision. The bid documents did not include caulking at the concrete expansion joints. The contractor was asked to perform this work. Work had to be done on a Saturday due to the curing time of the grout. The cost for item no. 2 includes the labor and material to grout expansion joints. **\$2,374**

Item # 3 – Moving of Planter Box's (PCO 25)

This change is the result of a District request. The bid documents did not include moving existing planters and troughs to the new garden area. The contractor was asked to perform this work on T&M. The cost for item no. 3 includes labor and equipment to move all of the planters and troughs. **\$2,237**

Item # 4 – Moving of Additional Sheds (PCO 4.1)

This change is the result of a District request. The bid documents for Stevenson Site Work does include to move these sheds. In order to help expedite the move of these sheds we asked Rodan to perform the work. A credit will be received from the Sitework contractor. The cost for item no. 4 includes the labor and equipment to relocate 3 storage sheds. **\$600**

Item # 5 – Relocation of Power Poles (PCO 28)

This change is the result of a design revisions. The temporary power poles needed to be relocated. They were installed to close to the Bldg. B building pad. This work had to be performed on a weekend because we had to shut down power at the school. The cost for item no. 5 includes labor, material and equipment to install new poles, splice boxes and additional cabling. **\$26,667**

Change Order 2 Summary Total Change Order No. 2 - \$46,098.00

Total of Stevenson Project - \$4,091,316.00

In our capacity as the District's Construction Manager we have completed a review of Change Order #2.

The additional cost of Change Order #2 is: \$46,098.00

The total Change Orders to date is \$ 341,316.00

This equates to 9.1% of the contract value. To date, Rodan Builders, Inc. construction has completed 100% of the contract work.

There is \$33,684.00 remaining in the Change Order Contingency.
